- IN THE ORDER PROPOSAL IT IS NECESSARY TO SPECIFY WHEN THE COLOURS ARE USED IN CONTRASTING TONALITIES.
- THE FOLLOWING PRODUCT RESPECTS THE EUROPEAN REGULATION REACH RULES.
- IN OUR PRODUCTION PROCESS, NO AZO DYES, WHICH ARE SUSCEPTIBLE TO THE RELEASE OF AROMATIC AMINES, PROHIBITED BY THE GERMAN REGULATION ON BASIC NECESSITIES AND LISTED IN ART.1, PARAGRAPH 2 OF DECREE BY THE GERMAN MINISTRY OF HEALTH ON 15/07/1994.
- COMPLIANCE WITH SPECIFIC REGULATIONS MUST BE REQUESTED AT THE TIME OF ORDER AND MUST BE CONFIRMED BY TORCITURA DI DOMASO SRL, WHICH WILL EVALUATE ITS FEASIBILITY AND COSTS.
- AFTER INDUSTRIAL WASHING THE PRODUCT COMPLIES WITH GB 18401:2010 REGULATION, B CATEGORY FOR THE PRODUCTS IN DIRECT CONTACT WITH THE SKIN, SINGLE FIBRE ANALYSIS METHOD. WE SUGGEST TO TEST THE COLOURS ANYWAY.
- -WE RECOMMEND THE USE OF 2 OR MORE THREADGUIDES ON MACHINE TO HAVE A STANDARDIZED EFFECT.
- -AFTER 20 DAYS FROM DELIVERY, LOSS OF PARAFFIN BEGINS WITH A FOLLOWING INCREASING OF FRICTIONS DURING THE WEAVING. -PLEASE TAKE CARE ON THE QUALITY OF THE SPOOLING IN CASE OF A NEW PARAFFINING. THE QUANTITY OF THE PARAFFIN MUST BE STANDARDIZED AND THE THICKNESS OF THE SPOOL MUST BE HOMOGENEOUS.
- -PAY ATTENTION ON SPEED AND THE VOLTAGE OF THE SPOOLING. IN CASE OF PROBLEM, PLEASE CONTACT OUR TECHNICAL DEPARTMENT. -THE ARTISANAL CONSTRUCTION OF THIS PRODUCT DETERMINES THE PRESENCE OF SOME KNOTS, PLEASE VALUE THE IMPACT ON THE FINISHED GARMENTS.
- -DO NOT MIX DIFFERENT LOTS.
- -DEFECTS DURING SAMPLING MUST BE TESTED BY OUR TECHNICAL DEPARTMENT WHICH HAS TO CONSIDER IF IT'S AN EXCEPTIONAL PROBLEM OR A DEFECT OF THE ARTICLE.
- -THE TECHNICAL WASTE IN KNITTING ON THIS KIND OF YARN IS AROUND 7%.
- -COMPLAINTS FOR QUANTITIES OVER 3 KGS ARE NOT ACCEPTED AND WE CANNOT ACCEPT COMPLAINTS ON FINISHED GARMENTS.
- -THE FORMALDEIDE CAN EXCEED OF 75 PPM VALUE IN SOME LOTS, THE INDUSTRIAL WASHING HELPS TO LOWER THIS VALUE UNDER 75 PPM. -WITH PRIOR NOTICE FROM CUSTOMERS, THE SPINNING MILL CAN MAKE IMPROVEMENT ONLY IF POSSIBLE.

WITH PRIOR NOTICE TO CUSTOMERS, WE RETAIN THE AUTONOY, ONLY IF POSSIBLE, TO MAKE QUALITY IMPROVEMENTS ON PRODUCT. THE CUSTOMER MUST VERIFY THAT THE PRODUCT, IN ACCORDANCE WITH THE SYMBOLS SUGGESTED BY US, MEETS ITS EXPECTATIONS AND THE ONES OF ITS CUSTOMERS.
